Unpredictable health-related disasters can be even more devastating for a small business owner, so we'll also discuss systems for maintaining up-to-date instructions for a "trustee" (family member or colleague) who can act on your behalf in dealing with clients and other business matters if you are suddenly incapacitated.

## Our Speakers

---

**Pilar Wyman**, Chief Indexer of Wyman Indexing since 1990 and Associate of Potomac Indexing since 2006, has been at the forefront of educating others about indexes for digital environments through her work with ASI's Digital Trends Task Force (DTTF) and through many workshops, presentations, and publications. She creates indexes in all formats as well as embedded indexes in Word and InDesign, and hyperlinked indexes. Her leadership and skills include the wider world of indexing as well. She oversaw the Best Practices for Indexing guide during her tenure as ASI president, and is ASI's International Representative and Chair of the Publication Committee. She is an active member of her local Mid-South Atlantic Chapter and is a founder of the Institute of Certified Indexers. She was an exam reviewer for the ASI Training in Indexing course for 6 years, and she taught the USDA Basic and Applied Indexing courses for 13 years. In her non-indexing life, she has had stints as a librarian, tech teacher, tech writer, and research assistant.

**Jan Wright**, of Wright Information Indexing Services, has decades of experience at the forefront of indexing in all its forms: ebooks, back-of-the-book indexes, text files, keywording, online indexing, video indexing, HTML and help file indexing, XML, and index-entry embedding within Word, InDesign, or FrameMaker files, in both Macintosh and Windows formats. In her work with the DTTP and through her presentations and publications, she has been instrumental in educating indexers, publishers, and EPUB standards groups about eBook and eContent indexing. InDesign CC's capacity to output active eBook indexes is one result of her work. Jan won the H.W. Wilson Award for Excellence in Indexing in 2009, was awarded the Hines Award in 2013, has taught indexing through USDA and UC Berkeley for many years, and has presented on technical indexing techniques at conferences around the world.

**Carolyn Weaver**, a founding member of the Pacific Northwest Chapter, has served as both President and Treasurer of ASI, and as an exam reviewer for the ASI Training in Indexing course. She is the recipient of the 2015 Hines Award and currently serves as PNW/ASI Treasurer. She was a medical librarian for 35 years, including 11 years as a moonlighting indexer, before transitioning to full-time indexing in 2000. Her indexing specialties include health, behavioral, and social sciences.

**Greg Bessert**, principal of Bessert Law Firm since 1992, is a frequent speaker for local organizations on taxation and also estate planning. A graduate of Oregon State University and Gonzaga Law School, Greg also holds an LL.M. in Tax Law from the University of Florida. ## Directions and traffic note

---

**Marriott Springhill Suites** is located at 1421 S.E. Tech Center Drive, Vancouver WA, less than 9 miles from the Portland International Airport (PDX).

Plan for heavy traffic on Friday afternoon, especially on I-5 northbound. If possible, arrive early and consider joining us for lunch at the Grant House and a tour of Fort Vancouver. (See Friday's agenda.)

### Southbound on I-5 (from Seattle)

1. Take I-5 to exit 7, I-205 south.
2. Take the exit for Highway 14 east.
3. Follow steps 4-6 below.

### Northbound on I-5/I-205 (from Eugene)

1. Take I-5 north to I-205.
2. Follow I-205 across the Columbia River into Washington.
3. Take the exit for Highway 14 east.
4. **Take exit 8 for 164th.**
5. **Left onto 164th, and drive until you reach Tech Center Drive (light after 15th)**
6. **Right onto Tech Center Drive. Hotel is on your right.**

### From Portland

1. Take I-5 or I-205 north across the Columbia River into Washington.
2. Take the exit for Highway 14 east.
3. Follow steps 4-6 above.

## Sherry Smith Award for a new indexer

---

The Sherry Smith Award of the Pacific Northwest Chapter of the American Society for Indexing will grant \$100 to help one new indexer per year attend a PNW fall conference. In order to apply, you must:

1. Be currently enrolled in an indexing course for initial training in indexing. This includes the ASI Training in Indexing course, the UC Berkeley Extension Indexing: Theory and Application course, or individual instruction from an established professional indexer.

OR

2. Be in your first year after completion of one of the courses above, as of the date of the fall conference.

AND

Apply no later than one month before the fall conference (August 15, 2018). Application is by email to the [membership coordinator](#), indicating your name, location, course/teacher, completion date if applicable, and contact information for verification.

Winner must be willing to volunteer for the Program Team for a one year period after selection, which is a group of indexers who help plan the fall conference. The purpose of the award is to help emerging indexers experience the benefits of networking with other indexers while we harness your ideas and energy to invigorate future conferences.

The winner will be selected by random drawing from the pool of applicants who meet the criteria. The winner will be awarded \$100 which will be allocated first towards the conference fee, and then any balance remaining will be paid to the winner at the conference to defray other conference-related travel costs. Conference attendance is required. Prior winners are not eligible.
