Our Speakers

Thérèse Shere has indexed more than a hundred and fifty cookbooks over the years, has taught cookbook indexing workshops around the country, and is the author of "Best Practices for Cookbooks" in "Best Practices for Indexing" (American Society for Indexing, 2015) and "Indexing Recipe Titles" in Indexing Specialties: Cookbooks (Information Today/American Society of Indexers, 2009). In her previous life, she worked for 20 years in the food business, including as restaurant cook and hostess, food magazine columnist, organic farmer, and bakery owner. She lives in Sonoma County, California – food and wine heaven.

Scott Smiley is a full-time freelance indexer who is currently president of PNW/ASI. A member of ASI since 1999 and of PNW/ASI since 2002, he previously served two terms as chapter treasurer. Scott was an instructor for the Graduate School (USDA) indexing course from 2009 until its demise in 2015, has a Ph.D. in geography, and was previously an accountant. He indexes primarily scholarly works in the social sciences, humanities, and other fields.

- 1. Take I-5 north to I-205.
- 2. Follow I-205 across the Columbia River into Washington.
- 3. Take the exit for Highway 14 east.
- 4. Take exit 8 for 164th.
- 5. Left onto 164th, and drive until you reach Tech Center Drive (light after 15th)
- 6. Right onto Tech Center Drive. Hotel is on your right.

From Portland

- 1. Take I-5 or I-205 north across the Columbia River into Washington.
- 2. Take the exit for Highway 14 east.
- 3. Follow steps 4-6 above.
