10 a.m.	The Logic and Language of Patterns: A Deeper Look for Cindex and SKY Index Users	Scott Smiley				
	Patterns, also called pattern matching or advanced find and replace, are a powerful tool for finding entries or for changing a whole set of entries that meet a particular criteria or "shape." They allow you to go beyond finding a particular word or letters to finding some particular combination characters. For example, suppose you need to find all numbers that are years, in the 1900s or 2000s; or suppose you need to take any text that is in parentheses (but letters only, not numbers) to change them into italics. With many of these scenarios, changing those entry by entry eats at the clock— but with patterns you can make these searches or replacements all at once—saving valuable project time.					
	However, patterns are difficult for many indexers to get their minds around. How do you decide if something will work with a pattern, and					

how do you figure out how to turn that problem into a pattern? How about all those darn symbols? For users of both Cindex and SKY Index, this workshop will explore the logic of patterns—how to think about

them, how to translate a problem into a pattern, and the language of patterns—those symbols that make up a pattern and tell the software what you want it to do.

Symbols for both SKY Index and Cindex will be covered, including the new pattern symbols in Cindex 3 (some have changed since Cindex 2). This will be a more in-depth



treatment of the topic than I have given previously, including a chance for workshop participants to bring their own pattern questions to discuss and problems to resolve. Whether you have used patterns in the past and wish to use them more (or "more better!"), or if you have never used patterns and want to explore new ways of making efficient use of your indexing software, this workshop is for you.

Scott Smiley has been a freelance indexer, ASI member, and Cindex user for over ten years. He moved to the Pacific Northwest in 2004 and promptly plunged into PNW/ASI, including serving on the chapter Board for the better part of six years (two terms as chapter treasurer and over a year filling in as Past President). Scott teaches the Basic Indexing course offered by The Graduate School USA (formerly USDA) and coordinates the Portland Indexers group.

Have you been asked to index a book that will be coming out with an e-book version? Join us as we cover the current state of indexes in e-books and devices—which has seen significant developments in the last year in the industry and though the efforts of the DTTF.



There are big issues facing readers who try to use an e-reader index, and big issues for publishers trying to make indexes work. We'll cover the problems indexers can discuss with clients, make sure you have a good understanding of the issues, and present some solutions so that you can recommend ideas to your clients.

A matrix of approaches to e-book indexing will also be covered. If you have an e-reader with indexed books on it, please bring it as part of the Digital Petting Zoo, when we all break up and look at examples of e-book interfaces, working indexes, and total failures.

Judi Gibbs Jan Wright **Jan Wright**, owner of Wright Information Indexing Services, has been indexing and taxonomizing since 1991. Her experience in indexing and book production includes her years as a professional librarian, as a print



production specialist in the Aldus Corporation documentation department, her work at Visio Corporation on the development of online help indexes and translated indexes, and her work for several Apple, Microsoft and Autodesk departments in indexing, taxonomies, and controlled vocabularies.

She has specialized in encoding and embedding indexing into documents,

allowing single-sourcing, translations, and repurposing materials into multiple output formats and versions. Much of her work is done in InDesign, FrameMaker, XML, and other embedding tools.

Jan has been a member of the American Society for Indexing since 1991, has won several awards from the Society for Technical Communication, and in 2009 won the ASI/H.W. Wilson Award for Excellence in Indexing for her index to *Real World InDesign CS3*, the first technical trade book to win the prestigious award.

Since 2011, she has co-chaired the American Society for Indexing's Digital Trends Task Force, which is focused on e-book and device-based indexing. She ushered ASI into membership with the International Digital Publishing Forum in order to get indexes included in EPUB 3.0 specifications, and co-wrote the Charter Document for the IDPF's Indexes Working



Group. In her DTTF role, she has focused on outreach to publishers, conversion houses, tool developers, and software manufacturers, and is serving as indexing's liaison to an Adobe InDesign working group focusing on better EPUB output. - From Interstate 205, take state Highway 14 west to Exit 1 toward the Vancouver National Historic Reserve. Turn left onto Columbia House Boulevard and follow Columbia under the railroad tracks to the Columbia Shores intersection. Turn east (left) at the Columbia Shores intersection onto SE Columbia Way and continue to head east about 3 miles. Follow the signs at the turnaround to the Center.

Lodging



PNW/ASI has a block of rooms available at discounted rates at the **Comfort Inn downtown Vancouver**, 401 E. 13th Street, approximately 4.5 miles west of the Water Resources Center (see directions below). These rates range from \$69 for a single to \$88 for a king. To take advantage of these special rates, call the Comfort Inn directly at (360) 696-0411 and mention "PNW-ASI" (or "Pacific Northwest indexers"). These rates are not available online.

This Comfort Inn serves a hot breakfast in the hotel's downstairs nook, which is included in the special rates listed above. Please be mindful that limited continental breakfast items and coffee will be available in the meeting room at the Water Resources Center, so you are advised to have breakfast on your own beforehand.

Directions from the Comfort Inn downtown Vancouver to the Water Resources Center (WRC): Drive west (away from I-5) on 13th Street to Columbia Street. Turn Left on Columbia Street and proceed about 3.5 miles to the WRC (Columbia St. changes to SE Columbia Way after you cross under the freeway). Follow the signs at the turnaround.

Other hotel options:

- Red Lion, 100 Columbia Street, (360) 694-8341. The Red Lion is three miles west of the Water Resources Education Center.
- Motel 6, 221 NE Chkalov Dr., (800) 466-8356. This is just off I-205 at Mill Plain, about 6 miles from the Water Resources Center.
- Homewood Suites by Hilton, 701 SE Columbia Shores Blvd., (360) 750-1100. This is the closest hotel to our meeting site, located on the river between the Red Lion and the Water Resources Center.
- Heathman Lodge, 7801 NE Greenwood Dr., (360) 254-31000. This is farther out (about 9 miles from the Water Resources Center). It is a national-park style lodge.
